

## **TERMS AND CONDITIONS**

    - i. After selecting the voucher from 'Hot Deals', click "Redeem" and then "Confirm" to claim the Deal.
    - ii. Deal is successfully redeemed.
    - iii. Click "View My Vouchers" button to view the claimed Deal.
  - c. How to use the e-voucher:
    - i. Member MUST be present at the Chatime outlet.



- ii. Open the Malaysia Airlines app, choose MHvoucher and tap the top right voucher icon.
- iii. Select the voucher that you want to use and Click "Use Now" button.
- iv. Click "Yes" button to confirm.
- v. QR code, Barcode and Text Code will be displayed and to be used at Merchant.
- vi. Present the e-voucher upon payment at the cashier.
- 6. Enrich Members are required to present the Special Privilege Discount e-voucher on Malaysia Airlines app upon payment at the cashier to be eligible for the privilege offer.
- 7. Only one (1) Special Privilege Discount e-voucher can be used per transaction.
- 8. An Enrich Member can claim up to ten (10) e-vouchers per month.
