

22% Bonus Enrich Points Domestic Flight Campaign Terms and Conditions

- 1. 22% Bonus Points Domestic Flight Campaign ("Promotion") is open to all Malaysia Airlines Enrich members ("Enrich Members") who purchase full fare ticket(s) for travel on Economy Class or Business Class on pure Malaysia Airlines operated flights to/from Domestic destinations.
- 2. This promotion is available at <u>malaysiaairlines.com</u>, Malaysia Airlines App, Malaysia Airlines Contact Centre, Malaysia Airlines Ticket Office (s) and Travel Agents.
- 3. Non-member can register for membership via Malaysia Airlines app or at https://enrich.malaysiaairlines.com/signup with code ENRSAVE and must register before purchasing flight ticket (s).
- 4. Enrich Members will be entitled to earn 22% Bonus Enrich Points on all Domestic destinations subject to the terms of the Promotion herein ("Bonus Enrich Points").
- 5. This Promotion is valid upon purchase of a full fare ticket for one-way/return journey on pure Malaysia Airlines operated flights only to/from Domestic destinations with ticket(s) issued on a MH (232) ticket document.
- 6. This Promotion will start Malaysia local time on 10 January 2022 at 00:00 (GMT+8) till 23 January 2022 end at 23:59 (GMT+8) ("Booking and Ticketing Period") and travel between 10 January 2022 till 30 June 2022 ("Travel Period").

- 7. Enrich Members will earn 22% Bonus Enrich Points over and above the Enrich Points earned for a completed Domestic destination.
- 8. This Bonus Enrich Points will not apply to tickets redeemed with Enrich Points, Points + Cash redemption, redemption upgrade, MHupgrade, Last Minute Upgrade, complimentary tickets or any form of upgrade.
- 9. This Bonus Enrich Points will not apply to airline staff tickets, agent discounted tickets using ATR (Air Travel Authority) and any form of discounted tickets. The campaign is only applicable to tickets purchased on full commercial fares.
- 10. The Bonus Enrich Points earned under this Promotion is not valid on MH3000, MH4000, MH5000, MH8000, MH9000 series, **one**world partner airlines, MASwings, Firefly, codeshare flights or flight jointly operated by other airlines.

12. There is no limit to the number of Bonus Enrich Points earned during this Promotion period.



- 13. The Bonus Enrich Points will be credited to the Enrich member's Account only after the member completes the journey, subject to fare class and flight eligibility.
- 14. The Bonus Enrich Points will be credited to the Enrich Member's account within fourteen (14) days after the end of this Campaign Period.
- 15. For any missing Points claim request, Bonus Enrich Points will be credited to the Enrich Member's account within six (6) to eight (8) weeks after the end of this Promotion ("Bonus Enrich Points Credit Period"). Any claim submitted after 6 months (180 days) will not be eligible.
- 16. Travel Date Change
 - Changes to travel date allowed within the booking and ticketing period subject to the fare rules of the ticket purchased.
 - Changes of travel date to an earlier or later flight or upsell to a higher fare class from the original date of travel booked is allowed provided the changes are made within the booking and ticketing promotion period as stated below:

- Change of travel date to an earlier date of travel or upsell to higher fare class from the original date after the campaign's booking/ticketing period is NOT allowed.
- Members will not be eligible for the Bonus Enrich Points if date of travel is changed to an earlier flight from the original booking date after the promotion booking period is over.
- Change of travel to a later date of travel from the original date purchased after the booking period, is allowed only on the same fare/booking class purchased and travel must be within the booking and ticketing promotion travel period. Changes will be subject to the fare rules purchased in terms of penalties and other relevant charges, if any.
- Upsell to a higher fare/booking class for a change of travel to a later date of travel from the original date purchased after the booking period, is NOT allowed.
- Ticket (s) purchased before this Promotion and rebooked with ticket reissued during this Promotion booking and ticketing period will not be eligible for the Bonus Enrich Points.
- Enrich members who do not turn-up for the flight (NO-SHOW) upon check-in and did not complete the journey will not be eligible for Bonus Enrich Points.
- Enrich members who are not able to complete the journey booked during the promotion travel period and use the ticket for travel after the travel period will not be eligible for Bonus Enrich Points.
- 17. This Promotion shall not be used in conjunction with any other promotional offer by Enrich or Malaysia Airlines Berhad ("Malaysia Airlines").
- 18. Flights that are not eligible for Enrich Points will not earn Bonus Enrich Points or Elite Points.
- 19. The flight (s) booked under this Campaign shall NOT contribute towards the accumulation of Elite Points required to qualify or upgrade to Enrich Elite tier status for year 2022.
- 20. This Bonus Enrich Points campaign does not apply to Elite Points.
- 21. This Bonus Enrich Points campaign does not apply to Elite Tier Bonus points accorded to respective top tier status.

- 31. If any matter arises which are not covered in these Terms and Conditions, they will be determined solely by Malaysia Airlines.

Conditions of Carriage, Malaysia Airlines rules and regulations, and Enrich Terms and Conditions.
