Terms and Conditions

EnrichMoney 1,000 Bonus Enrich Points New Sign-Up Promotion (hereinafter referred to as "**Promotion**") is subject to the following terms and conditions: -

Organiser

This Promotion is organised jointly by Enrich by Malaysia Airlines Berhad (hereinafter referred to as "Enrich") and Merchantrade Asia Sdn Bhd (hereinafter referred to as "Merchantrade"). Enrich and Merchantrade shall be collectively referred to as "Organiser".

Promotion Period

- 1. This Promotion will commence from 00:00:00 (Malaysia Time) on 05 July 2024 and end at 23:59:59 (Malaysia Time) on 31 December 2024 [both dates inclusive] ("**Promotion Period**").
- 2. Organiser reserves the right to amend or extend the duration of the Promotion at any time it deems fit, without prior notice and/or liability to any participant ("**Participant**").

Eligibility

- 1. This Promotion is open to new sign-ups for EnrichMoney Visa Prepaid Card.
- 2. Subject to **Clause 3** below, this Campaign is open to any individual of age twelve (12) years old and above who, during the Campaign Period, applies for EnrichMoney Visa Prepaid Card.
- 3. Cardholder(s) whose account has been suspended, cancelled or terminated before, during or after the Campaign Period are not entitled to participate in this Campaign.

Campaign Mechanism and Fulfilment Conditions

1. Subject to the Terms and Conditions herein, Participant will be entitled for 1,000 Bonus Enrich Points when he/she has successfully applied for EnrichMoney Visa Prepaid Card during the Promotion Period.





2. To be eligible to participate in this Promotion, Participant must perform a minimum initial topup into EnrichMoney e-Wallet following age categories below.

1,000 Bonus Enrich Points

- 1. The first 5,000 eligible EnrichMoney Cardholders, who sign up and top up on EnrichMoney within the Promotion Period, will receive 1,000 Bonus Enrich Points that will be credited into their respective Enrich Account.
- 2. The 1,000 Bonus Enrich Points will be credited into the first 5,000 eligible EnrichMoney Cardholders' Enrich Account within fourteen (14) working days after the EnrichMoney Cardholder completes the sign up and top up.
