

## FOR AMBANK ENRICH VISA INFINITE CARDHOLDERS

### TERMS & CONDITIONS:

1. The Principal Cardholder of AmBank Enrich Visa Infinite is entitled to access the Malaysia Airlines Golden Lounge in KL International Airport in the following manner:

Malaysia Airlines Golden Lounge Access (GLA) e-voucher	<p>Unlimited Complimentary Access  <i>(Principal Cardholder and one (1) guest per entry)</i>  <i>*01 GLA voucher at a time</i>  <i>*cardholder can only redeem max. 2 GLA e-vouchers per flight</i></p>

2. Golden Lounge Access Voucher for AmBank Enrich Visa Infinite Card is applicable to the Principal Cardholder only.
3. The Golden Lounge Access e-voucher is NOT valid at third (3<sup>rd</sup>) party lounges (lounges not operated by Malaysia Airlines) and oneworld lounges. The list of the Malaysia Airlines Golden Lounge outlets operated by Malaysia Airlines are as follows:
  - i. KLIA International Airport Golden Lounge Domestic,
  - ii. KLIA International Airport Golden Lounge Regional, and
  - iii. KLIA International Airport Golden Lounge Satellite
4. The AmBank Enrich Golden Lounge Access Voucher is applicable when travelling on a pure Malaysia Airlines operated flight with an MH flight number and ticketed on Malaysia Airlines (232) document. The utilization of the AmBank Enrich GLA e-voucher is available prior to departure on date of travel only.
5. Golden Lounge Access Voucher for AmBank Enrich Visa Infinite Card can be extended to the Eligible Principal Cardholder's companion who is travelling on the same flight and date together with the Eligible Principal Cardholder.
6. This Golden Lounge Access is not extended to AmBank Enrich Visa Infinite Supplementary Cardholders who travel on their own or with a companion.
7. This AmBank Enrich Visa GLA e-voucher is an exclusive benefit to AmBank Enrich Visa Cardholders. At time of use, the cardholder using the AmBank Enrich Visa GLA e-voucher may be required to present his/her identification which includes but not limited to Malaysia Airlines Boarding Pass, Identity Card or Passport, and/or AmBank Enrich Visa Card prior to entry.
8. If the Principal Cardholder is holding an AmBank Enrich Visa Infinite Card, **ONLY ONE (1) PRIVILEGE** can be utilized at one time (either Gold/Platinum privilege or AmBank Enrich Visa Infinite Credit Card privilege).
9. The Eligible Cardholder and his/her travelling companion are to adhere to, amongst others, the following:
  - i. The Principal Cardholder is required to download the Malaysia Airlines mobile app in order to access the Golden Lounge Access Voucher.

- ii. The Golden Lounge Access Voucher must be presented at the lounge reception desk together with Malaysia Airlines boarding pass.
  - iii. The Golden Lounge Access Voucher is valid as stated in the voucher. The validity of the Golden Lounge Access Voucher cannot be extended and once expired, is deemed void.
10. The number of AmBank Enrich Visa GLA e-voucher entitled for each Cardholder is indicated herein. All GLA e-vouchers must be redeemed within the voucher validity. Once expired, it is deemed void and no further extension is allowed.
11. The Golden Lounge Access Voucher is not transferrable nor exchangeable for cash or in any kind.
12. The Golden Lounge Access Voucher is not valid if the travel is on Oneworld, partner airline, codeshare and any Malaysia Airlines marketed/ operated flights with any partners airlines.
13. The Principal Cardholder agrees that the Principal Cardholder's access to the Golden Lounge shall be governed by the Malaysia Airlines Golden Lounge's Terms and Conditions at [www.malaysiaairlines.com/my](http://www.malaysiaairlines.com/my) which may be amended from time to time without any prior notice.
14. The Golden Lounge Voucher earned will be automatically revoked upon cancellation or termination of the Card.
