



## TERMS AND CONDITIONS

## ENRICH POINTS REDEMPTION FOR E-DONATION

  - b) Enrich member's full name
  - c) NRIC/Passport no.
  - d) Registered mailing address
  - e) Registered email address
  - f) Phone no.
  - g) Amount donated
  - h) Date
- 13. Enrich Members are to expect an official tax exemption receipt within four (04) months from the date of every successful redemption. The tax exemption receipt will be sent to the Member's registered email address with Enrich.
- 14. The Organizer is not liable for Make-A-Wish Malaysia's failure or delay in providing the services to Enrich Members.
- 15. The Organizer and Make-A-Wish Malaysia reserves the right at any time to change, modify or cancel the Promotion rules including regulations, benefits and conditions of participation.
