



## TERMS AND CONDITIONS

## ENRICH POINTS REDEMPTION FOR E-DONATION

- 4. The e-donation can only be redeemed at Malaysia Airlines mobile app and Enrich Online (<a href="https://enrich.malaysiaairlines.com/login">https://enrich.malaysiaairlines.com/login</a>) and may not be redeemed or purchased with cash or credit card directly.
- 5. Once redeemed, the e-donation is non-refundable and cannot be exchanged for cash in part or full.
- 6. The appropriate Enrich Points will be deducted from the Member's Enrich account and will not be refunded under any circumstances.
- 7. The redemption is on full Points term only; no Points + Cash term is allowed.

Please be advised that Enrich and Buddhist Tzu-Chi Merits Society Malaysia have officially signed a PDPA document, and this information will only be exchanged for the purpose of issuance of an official tax exemption receipt as advised by Lembaga Hasil Dalam Negeri Malaysia (Inland Revenue Board of Malaysia) guidelines under Subsection 44(6) of the Income Tax Act 1967:
  - a) Enrich membership ID
  - b) Enrich member's full name
  - c) NRIC/Passport no.
  - d) Registered mailing address
  - e) Registered email address
  - f) Phone no.
  - g) Amount donated
  - h) Date
- 13. Enrich Members are to expect an official tax exemption receipt within four (04) months from the date of every successful redemption. The tax exemption receipt will be sent to the Member's registered email address with Enrich.
- 14. The Organizer is not liable for Buddhist Tzu-Chi Merits Society Malaysia's failure or delay in providing the services to Enrich Members.
- 15. The Organizer and Buddhist Tzu-Chi Merits Society Malaysia reserves the right at any time to change, modify or cancel the Promotion rules including regulations, benefits and conditions of participation.
