



TERMS AND CONDITIONS

REDEMPTION ON ENRICH POINTS FOR BASKIN ROBBINS E-GIFTCARD

(MALAYSIA ONLY)

[A] Redemption of Baskin Robbins e-Giftcard

- 1. The Baskin Robbins e-Giftcard (s) is available for redemption during the campaign period published in Enrich Website in a denomination offered with the amount of Enrich Points required specified in the campaign terms and conditions.
- 2. The Baskin Robbins e-Giftcard can only be redeemed on Malaysia Airlines mobile app and Enrich Online (https://enrich.malaysiaairlines.com/login) and may not be redeemed or purchased with cash or credit card directly at any Baskin Robbins stores.
- 3. The amount of Enrich Points required for the Baskin Robbins e-Giftcard is as follows: -
 - 1,800 Enrich Points for one (1) MYR 30 Baskin Robbins e-Giftcard
 - 3,000 Enrich Points for one (1) MYR 50 Baskin Robbins e-Giftcard
- 4. The redemption period is from now until 28th February 2025.
- 5. The Redemption is on full Points term only; no Points and Cash terms is allowed.
- **6.** Once redeemed, the redemption is non-refundable and cannot be exchanged for cash in part or full.
- 7. The appropriate Enrich Points will be deducted from the member's Enrich account and will not be refunded under any circumstances.
- 8. Enrich Member must have sufficient Points in their Enrich account to perform this redemption. In the event, Member does not have sufficient Points, redemption request will not be processed and top up with cash/credit card is strictly not allowed.
- 9. Enrich Member may opt to purchase Enrich Points via their Enrich account online as top up to be able to perform this Enrich GiftCard redemption.
- **10**. Enrich Points from one Enrich account cannot be combined with another Enrich account to redeem for this Enrich GiftCards.
- 11. Once redemption is successful, a Redemption Confirmation Order Email will be sent to the member's registered email address in the Enrich Profile.
- 12. The e-voucher can only be downloaded by the member who redeems the voucher. Transfer of the e-voucher to other Enrich member (s) is not allowed.
- 13. Redemption for this e-GiftCard is subject to availability.

[B] Usage of Baskin Robbins e-Giftcard

- 1. The usage of this e-Giftcard is for purchase of Baskin Robbins products that is valid in <u>Malaysia</u> only.
- 2. The value of this e-Giftcard is in Malaysian Ringgit (MYR).
- 3. The e-Giftcard format: Voucher Code and Bar Code
- 4. The e-Giftcard validity once redeemed: valid until 28 February 2025.
- 5. The Baskin Robbins e-Giftcard can only be used at <u>physical stores</u> at: <u>https://www.baskinrobbins.com.my/content/baskinrobbins/en/location.html, except</u> Genting First World, Genting Highlands Hotel and Genting Premium Outlet.





- **6.** The e-Giftcard is not applicable to promotional items.
- 7. This e-GiftCard can only be used once and must be shown to the cashier of the participating store to be scanned into the Point-of-Sale system upon payment check-out. Once successful, the cash balance is then automatically deducted, and customer will need to check the total payable amount before complete payment.
- 8. In order to utilize the e-Giftcard at **physical stores**, Enrich Member is required to follow the steps below:
 - a. Login to Malaysia Airlines mobile app.
 - b. Tab on MHVoucher, then select My Voucher to view your Active Voucher.
 - c. Select the voucher to utilize and click 'USE NOW'.
 - d. The voucher code and barcode will appear.
 - e. Present the code to the Cashier at the physical store.
 - f. Once successful, RM30 or RM50 will be deducted from the total bill.

Note: For physical store redemption, please ensure you are at the merchant store before you click 'USE NOW'. The 'USE NOW' tab can only be clicked ONCE and this action cannot be reversed.

- 9. The e-Giftcard is only good for a one-time use only.
 - If the total purchase is less than the value of the e-Giftcard, no refunds will be given.
 - If the total purchase is more than the value of the e-Giftcard, you are required to pay the balance by cash/credit card, subject to applicable taxes and charges.
- 10. Only valid e-Giftcard will be accepted. Photocopied, reproduced, defaced or not scannable/unclear, expired e-Giftcard will not be accepted.
- 11. The e-Giftcard can be combined up to three (03) vouchers with the same denomination value at one time.
- 12. The e-Giftcard validity is limited in time and such validity period stated. There will be no reissuance of the e-Giftcard upon the expiry date. No replacements, extension, no refund in cash will be given for expired e-Giftcard.
- **13**. The e-Giftcard is not usable with other voucher denominations i.e.: MYR 30 Giftcard cannot be combined with MYR 50 Giftcard and vice versa.
- **14.** Baskin Robbins (Golden Scoop) and Enrich will not be liable and/or be required to offer replacement e-Giftcard, discounts, credits, cash or otherwise compensate customers for:
 - incorrectly redeeming for this e-Giftcard on Enrich Online
 - loss, theft, fraud, cancelled, damaged, discontinued or the member's public disclosure of the e-Giftcard.
 - improper use of, or inability to redeem, e-Giftcard; or
 - the inability to redeem the e-Giftcard due to technical issues.
