



#### **TERMS AND CONDITIONS**

#### REDEMPTION ON ENRICH POINTS FOR BATH & BODY WORKS E-GIFTCARD

#### (MALAYSIA ONLY)

### [A] Redemption of Bath & Body Works e-Giftcard

- 1. The Bath & Body Works e-Giftcard (s) is available for redemption during the campaign period published in Enrich Website in a denomination offered with the amount of Enrich Points required specified in the campaign terms and conditions.
- 2. The Bath & Body Works e-Giftcard can only be redeemed on Malaysia Airlines mobile app and Enrich Online (<a href="https://enrich.malaysiaairlines.com/login">https://enrich.malaysiaairlines.com/login</a>) and may not be redeemed or purchased with cash or credit card directly at any Bath & Body Works stores.
- 3. The amount of Enrich Points required for the Bath & Body Works e-Giftcard is as follows: -
  - 1,800 Enrich Points for one (1) MYR 30 Bath & Body Works e-Giftcard
  - 3,000 Enrich Points for one (1) MYR 50 Bath & Body Works e-Giftcard
- 4. The redemption period is from now until 28th February 2025.

- 3. The e-Giftcard format: Card number, Card PIN, Bar Code
- 4. The e-Giftcard validity once redeemed: 365 days from date of issue
- 5. The Bath & Body Works e-Giftcard can only be used at <a href="mailto:physical stores">physical stores</a> in Malaysia except at the airports. - 6. In order to utilize the e-Giftcard at **physical stores**, Enrich Member is required to follow the steps below:

  - b. Tab on MHVoucher, then select My Voucher to view your Active Voucher.
  - c. Select the voucher to utilize and click 'USE NOW'.
  - d. The card number, card PIN and barcode will appear.
  - e. Present the code to the Cashier at the physical store.
  - f. Once successful, RM30 or RM50 will be deducted from the total bill.

Note: For physical store redemption, please ensure you are at the merchant store before you click 'USE NOW'. The 'USE NOW' tab can only be clicked ONCE and this action cannot be reversed.
