

## TERMS AND CONDITIONS

### REDEMPTION ON ENRICH POINTS FOR MYDIN E-GIFTCARD

#### (MALAYSIA ONLY)

#### **[A] Redemption of MYDIN e-Giftcard**

1. The MYDIN e-Giftcard (s) is available for redemption during the campaign period published in Enrich Website in a denomination offered with the amount of Enrich Points required specified in the campaign terms and conditions.
2. The MYDIN e-Giftcard can only be redeemed on Malaysia Airlines mobile app and Enrich Online (<https://enrich.malaysiaairlines.com/login>) and may not be redeemed or purchased with cash or credit card directly at any MYDIN stores.
3. The amount of Enrich Points required for the MYDIN e-Giftcard is as follows: -
  - 1,200 Enrich Points for one (1) MYR 20 MYDIN e-Giftcard
  - 3,000 Enrich Points for one (1) MYR 50 MYDIN e-Giftcard
  - 6,000 Enrich Points for one (1) MYR100 MYDIN e-Giftcard
4. The redemption period is from now until **28<sup>th</sup> February 2025**.
5. The Redemption is on full Points term only; no Points and Cash terms is allowed.
6. Once redeemed, the redemption is non-refundable and cannot be exchanged for cash in part or full.
7. The appropriate Enrich Points will be deducted from the member's Enrich account and will not be refunded under any circumstances.
8. Enrich Member must have sufficient Points in their Enrich account to perform this redemption. In the event, Member does not have sufficient Points, redemption request will not be processed and top up with cash/credit card is strictly not allowed.
9. Enrich Member may opt to purchase Enrich Points via their Enrich account online as top up to be able to perform this Enrich GiftCard redemption.
10. Enrich Points from one Enrich account cannot be combined with another Enrich account to redeem for this Enrich GiftCards.
11. Once redemption is successful, a Redemption Confirmation Order Email will be sent to the member's registered email address in the Enrich Profile.
12. The e-GiftCard cannot be exchanged or substituted for other redemption campaign or other promotions offered by Malaysia Airlines.
13. The e-voucher can only be downloaded by the member who redeems the voucher. Transfer of the e-voucher to other Enrich member (s) is not allowed.
14. Redemption for this e-GiftCard is subject to availability.

#### **[B] Usage of MYDIN e-Giftcard**

1. The Mydin Gift Card can be used to make any purchases ONLY at Mydin stores except for purchase of other Mydin GiftCards.
2. The value of this e-Giftcard is in Malaysian Ringgit (MYR).
3. The e-GiftCard cannot be exchanged for Cash/Gift Cards/Credit Notes. No cash refund in part / full will be provided.

4. The e-GiftCard is to be treated like cash. It cannot be replaced if lost, stolen or damaged
5. The e-GiftCards are reloadable for future purchases at Mydin stores.
6. The e-Giftcard format: 26 Digit Barcode
7. The e-Giftcard validity once redeemed: 365 days from date of issue
8. The e-GiftCard can only be used once and must be shown to the cashier of the participating store to be scanned into the Point-of-Sale system upon payment check-out. Once successful, the cash balance is then automatically deducted, and customer will need to check the total payable amount before complete payment.
9. In order to utilize the e-Giftcard at **physical stores**, Enrich Member is required to follow the steps below:
  - a. Login to Malaysia Airlines mobile app.
  - b. Tab on MHVoucher, then select My Voucher to view your Active Voucher.
  - c. Select the voucher to utilize and click 'USE NOW'.
  - d. The Bar Code will appear.
  - e. Present the code to the Cashier at the physical store.
  - f. Once successful, RM20, RM50 or RM100 will be deducted from the total bill.

*Note: For physical store redemption, please ensure you are at the merchant store before you click 'USE NOW'. The 'USE NOW' tab can only be clicked ONCE and this action cannot be reversed.*

10. The e-GiftCard is only good for a one-time use only and needs to be used in full.
  - If the total purchase is less than the value of the e-GiftCard, no refunds will be given.
  - If the total purchase is more than the value of the e-GiftCard, you are required to pay the balance by cash/credit card.
11. Only valid e-Gift Cards will be accepted. Photocopied, reproduced, defaced, expired or not scannable/unclear e-GiftCard will not be accepted.
12. The e-GiftCard can be combined up to five (05) in single transactions. If the value of your order exceeds the value of the Gift Card, any outstanding order balance must be paid using any payment methods accepted by Mydin.
13. The e-GiftCard validity is limited in time and such validity period stated. There will be no re-issuance of the e-GiftCard upon the expiry date. No replacements, extension or refund in cash will be given for expired e-GiftCard.
14. Mydin Mohamed Holdings Bhd. and Enrich will not be liable and/or be required to offer replacement e-GiftCard, discounts, credits, cash or otherwise compensate customers for:
  - incorrectly redeeming for this e-GiftCard on Enrich Online
  - loss, theft, fraud, cancelled, discontinued, damaged or the member's public disclosure of the e-GiftCard.
  - improper use of, or inability to redeem, e-GiftCard; or
  - the inability to redeem the e-GiftCard due to technical issues.
15. Mydin Mohamed Holdings Bhd. will not be responsible for lost card and no demand for replacement / compensation for the lost code will be entertained.
16. Mydin Mohamed Holdings Bhd. reserves the right to amend the e-GiftCard usage terms & conditions at its discretion without prior notice.

Request after **three (03) days** from the date of redemption will not be entertained and will be deemed as redeemed and utilized. No Points refund or replacement of e-GiftCard will be accommodated.
