



TERMS AND CONDITIONS

REDEMPTION ON ENRICH POINTS FOR STEVE MADDEN E-GIFTCARD

(MALAYSIA ONLY)

[A] Redemption of STEVE MADDEN e-Giftcard

- 1. The STEVE MADDEN e-Giftcard (s) is available for redemption during the campaign period published in Enrich Website in a denomination offered with the amount of Enrich Points required specified in the campaign terms and conditions.
- 2. The STEVE MADDEN e-Giftcard can only be redeemed on Malaysia Airlines mobile app and Enrich Online (https://enrich.malaysiaairlines.com/login) and may not be redeemed or purchased with cash or credit card directly at any STEVE MADDEN stores.
- 3. The amount of Enrich Points required for the STEVE MADDEN e-Giftcard is as follows: -
 - 1,800 Enrich Points for one (1) MYR30 STEVE MADDEN e-Giftcard
 - 3,000 Enrich Points for one (1) MYR50 STEVE MADDEN e-Giftcard
- 4. The redemption period is from now until 28th February 2025.
- 5. The Redemption is on full Points term only; no Points and Cash terms is allowed.
- **6.** Once redeemed, the redemption is non-refundable and cannot be exchanged for cash in part or full.
- 7. The appropriate Enrich Points will be deducted from the member's Enrich account and will not be refunded under any circumstances.
- 8. Enrich Member must have sufficient Points in their Enrich account to perform this redemption. In the event, Member does not have sufficient Points, redemption request will not be processed and top up with cash/credit card is strictly not allowed.
- 9. Enrich Member may opt to purchase Enrich Points via their Enrich account online as top up to be able to perform this Enrich GiftCard redemption.
- **10.** Enrich Points from one Enrich account cannot be combined with another Enrich account to redeem for this Enrich GiftCards.
- 11. Once redemption is successful, a Redemption Confirmation Order Email will be sent to the member's registered email address in the Enrich Profile.
- **12.** The e-GiftCard cannot be exchanged or substituted for other redemption campaign or other promotions offered by Malaysia Airlines.
- 13. The e-voucher can only be downloaded by the member who redeems the voucher. Transfer of the e-voucher to other Enrich member (s) is not allowed.
- 14. Redemption for this e-GiftCard is subject to availability.

[B] Usage of STEVE MADDEN e-Giftcard

- 1. The usage of this e-Giftcard for purchase of Steve Madden is valid in Malaysia only.
- 2. The value of this e-Giftcard is in Malaysian Ringgit (MYR).
- 3. The e-GiftCard format: Card number, Card PIN, Bar Code
- 4. The e-Giftcard validity once redeemed: 365 days from date of issue
- 5. The STEVE MADDEN e-GiftCard can only be used at <u>physical stores in Malaysia</u> except at the airports. For more information, please go to: https://valiram.com/steve-madden/store-locator/





- 6. In order to utilize the e-Giftcard at **physical stores**, Enrich Member is required to follow the steps below:
 - a. Login to Malaysia Airlines mobile app.
 - b. Tab on MHVoucher, then select My Voucher to view your Active Voucher.
 - c. Select the voucher to utilize and click 'USE NOW'.
 - d. The Card number, Card PIN and Bar Code will appear.
 - e. Present the code to the Cashier at the physical store.
 - f. Once successful, RM30 or RM50 will be deducted from the total bill.

Note: For physical store redemption, please ensure you are at the merchant store before you click 'USE NOW'. The 'USE NOW' tab can only be clicked ONCE and this action cannot be reversed.
