

TERMS AND CONDITIONS

REDEMPTION ON ENRICH POINTS FOR ZALORA E-GIFTCARD

(SINGAPORE ONLY)

[A] Redemption of ZALORA e-GiftCard

1. The ZALORA e-Giftcard (s) is available for redemption during the campaign period published in Enrich Website in a denomination offered with the amount of Enrich Points required specified in the campaign terms and conditions.
2. Enrich Member are to log in to their Enrich account to redeem their Enrich Points for the Enrich GiftCards.
3. The ZALORA e-Giftcard can only be redeemed on Malaysia Airlines mobile app and Enrich Online (<https://enrich.malaysiaairlines.com/login>) and may not be purchased with cash or credit card.
4. The amount of Enrich Points required for the ZALORA e-GiftCard is as follows: -
 - 6,500 Enrich Points for one (1) SGD 20 ZALORA e-GiftCard
 - 12,500 Enrich Points for one (1) SGD 50 ZALORA e-GiftCard
5. The redemption period is from now until **28th February 2025**.
6. The Redemption is on full Points term only; no Points and Cash terms is allowed
7. Once redeemed, the redemption is non-refundable and cannot be exchanged for cash in part or full.
8. The appropriate Enrich Points will be deducted from the member's Enrich account and will not be refunded under any circumstances.
9. Enrich Members must have sufficient Points in their Enrich account to perform this redemption. In the event, Member do not have sufficient Points, redemption request will not be processed and top up with cash/credit card is strictly not allowed.
10. Enrich Member may opt to purchase Enrich Points via their Enrich account online as top up to be able to perform this Enrich GiftCard redemption.

12. Once redemption is successful, a Redemption Confirmation Order Email will be sent to the member's registered email address in the Enrich Profile.
13. The e-voucher can only be downloaded by the member who redeems the voucher. Transfer of the e-voucher to other Enrich member (s) is not allowed.
14. The e-GiftCard cannot be exchanged or substituted for other redemption campaign or other promotions offered by Malaysia Airlines.
15. Redemption for this e-voucher code is subject to availability.

[B] Usage of ZALORA e-GiftCard

1. The usage of this e-GiftCard is ONLY applicable at only at www.zalora.sg or ZALORA mobile application.
2. The value of this e-GiftCard is in Singapore Dollar (SGD).
3. The e-GiftCards cannot be exchanged for Cash/Gift Cards/Credit Notes. No cash refund in part / full will be provided.
4. The e-GiftCards are non-refundable and non-transferable.

5. The e-GiftCards are non-reloadable.
6. The e-GiftCard format: Alphanumeric Codes
7. The e-GiftCard validity once redeemed: 365 days from date of issue
8. The e-GiftCard can only be used once. Products purchased using a e-GiftCards are not refundable in cash but only store credit.
9. To use the ZALORA e-GiftCard, please click My Account and go to Store Credit to enter the e-GiftCard code. Enrich Member is required to apply the credit upon making payment at the checkout page.
10. Amount of store credits held in the Zalora Wallet shall not exceed S\$1,000 (or the equivalent in the local currency) at any one time.
11. The e-GiftCard is only good for a one-time use only.
 - If the total purchase is less than the value of the e-GiftCard, a store credit shall be issued for unused part of the e- GiftCard.
 - If the total purchase is more than the value of the e-GiftCard, you are required to pay the balance by cash/credit card.
12. Only valid e-Gift Cards will be accepted. Photocopied, reproduced, defaced or expired e-GiftCard will not be accepted.
13. The e-GiftCard can be combined with no maximum capping in single transactions.
14. The e-GiftCard validity is limited in time and such validity period stated. There will be no re-issuance of the e-GiftCard upon the expiry date. No replacements, extension or refund in cash will be given for expired e-GiftCard.
15. ZALORA and Enrich will not be liable and/or be required to offer replacement e-GiftCard, discounts, credits, cash or otherwise compensate customers for:
 - incorrectly redeeming for this e-GiftCard on Enrich Online
 - loss, theft, fraud, cancelled, discontinued, damaged or the member's public disclosure of the e-GiftCard.
 - improper use of, or inability to redeem, e-GiftCard; or
 - the inability to redeem the e-GiftCard due to technical issues.
16. ZALORA will not be responsible for lost card and no demand for replacement / compensation for the lost code will be entertained.
17. In order to utilize the e-Giftcard at **online stores**, Enrich Member is required to follow the steps below:
 - a. Login to Malaysia Airlines mobile app.
 - b. Tab on MHVoucher, then select My Voucher to view your Active Voucher.
 - c. Select the voucher to utilize and click 'USE NOW'.
 - d. The Alphanumeric Codes will appear.
 - e. Visit the online store, key in the codes upon checkout.
 - f. Once successful, SGD20 or SGD50 will be deducted from the total bill.
18. ZALORA reserves the right to amend the e-GiftCard usage terms & conditions at its discretion without prior notice.
19. The Terms of Service set out at <https://www.zalora.sg/terms-of-use/> shall apply to all uses of the e-GiftCard.
20. Members are to contact Enrich at enrich@malaysiaairlines.com immediately from the date of redemption to report any issues pertaining to the redemption of this e-GiftCard. Request after **three (03) days** from the date of redemption will not be entertained and will deemed as redeemed and utilized. No Points refund or replacement of e-GiftCard will be accommodated.
