

ENRICHMONEY YEAR END CRAZY HOUR GET ADDITIONAL 10% BONUS ENRICHMONEY POINTS

Terms and Conditions

ORGANISER

PROMOTION PERIOD

1. The Promotion is valid for nine (9) days, from **23 December 2024 to 31 December 2024**, and is only applicable between 18:00H and 21:00H (Malaysia Time) each day (“**Promotion Period**”), inclusive of both start and end dates.
2. Organiser reserves the right to amend or extend the duration of the Promotion at any time it deems fit, without prior notice and/or liability to any participant (“**Participant**”).

ELIGIBILITY

1. This Promotion is open to all Enrich Member who have signed up for EnrichMoney Visa Prepaid Card.
2. EnrichMoney Visa Prepaid Cardholder(s) whose account has been suspended, cancelled or terminated before, during or after the Promotion Period will not be eligible to participate in this Promotion.
3. If you are not an EnrichMoney Cardholder, you may apply by downloading the EnrichMoney mobile application (“**EnrichMoney app**”) from [Google Play Store](#) or [Apple AppStore](#) and sign up as a cardholder.

PROMOTION MECHANISM

1. Subject to the Terms and Conditions herein, Participant will be entitled to receive **an additional 10% Bonus EnrichMoney Points** for every successful point top-up transacted during the Promotion Period. Participant is required to convert Enrich Points into EnrichMoney Points balance by clicking ‘Add Points’ within the EnrichMoney app.
2. To be eligible for this Promotion, Participant must add a **minimum** of ten (10) Enrich Points into EnrichMoney eWallet during each top-up.
3. One (1) Enrich Point equals to one (1) EnrichMoney Point applies for every point conversion transacted.

owner of both accounts.

5. Top-up from Enrich Points to EnrichMoney Points are non-reversible.

7. To ascertain if the Participant is eligible for the Bonus EnrichMoney Points, the Organiser shall rely upon its system in its decision. In the event of any dispute or disagreement, the Organiser's decision will be deemed final.

ADDITIONAL 10% BONUS ENRICHMONEY POINTS

1. The additional 10% Bonus EnrichMoney Points will be awarded based on every successful EnrichMoney Points top-up transaction which, are rounded down to the nearest points in the integer. Calculation is illustrated as below:

No.	EnrichMoney Points Topped Up	Additional Bonus EnrichMoney Points
1	11	= 11 x 10% = 1.10 = 1 (<i>rounded down to the nearest integer</i>)
2	105	= 105 x 10% = 10.50 = 10 (<i>rounded down to the nearest integer</i>)

2. The Additional Bonus EnrichMoney Points will be awarded and credited into the EnrichMoney Points balance within fourteen (14) working days after the official transaction. EnrichMoney Points awarded will be notified via EnrichMoney in-app push notification.
3. The EnrichMoney Points and Bonus EnrichMoney Points awarded is valid for one (1) year from the date credited. These Bonus EnrichMoney Points will not be eligible for extension if not used within the one-year validity specified.
4. The EnrichMoney Points awarded may be used to redeem for cashback for a purchase post-transaction. Use of EnrichMoney Points shall be subject to [EnrichMoney Terms](#).
