# Redemption of Enrich Optimax RM100 e-Voucher

The Enrich and Optimax RM100 e-Voucher Redemption Campaign is organized by Enrich by Malaysia Airlines Berhad (Company No. 201401040794 (1116944-X) a company incorporated in Malaysia and having its registered office at Level 1, South Support Zone, 64000 Sepang, Selangor, Malaysia (hereinafter referred to "Organizer")

And

Optimax Eye Specialist Centre Sdn Bhd (Registration 329776-D), a company incorporated in Malaysia and having its registered office at 145-1, Jalan Radin Bagus, Sri Petaling, 57000 Kuala Lumpur, Malaysia (hereinafter referred to as "Optimax Eye Specialist Centre")

### [A] Redemption of Enrich Optimax RM100 e-Voucher

- 1. The Enrich Optimax RM100 e-Voucher is available for redemption during the campaign period published in Enrich Website in a denomination offered with the amount of Enrich Points required specified in this campaign terms and conditions.
- 2. The amount of Enrich Points required for this redemption campaign is **6,000 Enrich Points** for one (1) Enrich Optimax RM100 e-Voucher.
- 3. The campaign period is as follow:
  - Redemption period : 1 March 2024 25 February 2026
  - Usage period : Six (06) months from date of successful redemption
- 4. The Enrich Optimax RM100 e-Voucher can only be redeemed at Enrich Online (<a href="https://www.enrich.malaysiaairlines.com/enrich.html">https://www.enrich.malaysiaairlines.com/enrich.html</a>) and may not be redeemed or purchased with cash or credit card directly at any Optimax Eye Specialist Centre outlets.
- 5. Once redeemed, the Enrich Optimax RM100 e-Voucher is non-transferable, non-refundable and cannot be exchanged for cash in part or full.
- 6. The appropriate number of Enrich Points will be deducted from the member's Enrich account and will not be refunded under any circumstances. Once the Enrich Optimax RM100 e-Voucher has been redeemed, it is considered utilized even if not used.
- 7. Enrich Member must have sufficient Points in their Enrich account to redeem the Enrich Optimax RM100 e-Voucher. In the event where Member does not have sufficient Points, the redemption request will not be processed and top up with cash/credit card is strictly not allowed.
- 8. The Redemption is on full Points term only; no Points + Cash terms is allowed.

- 1. The Enrich Optimax RM100 e-Voucher(s) is valid at participating Optimax Eye Specialist Centre outlets in Malaysia and can be used one-time only.
- 2. Combination of multiple Enrich Optimax RM100 e-Vouchers, **up to 50 e-Vouchers** (worth RM5,000) is allowed in a single transaction.
- 3. In order to utilize the Enrich Optimax RM100 e-Voucher(s), Enrich Member is required to follow the steps





in the Redemption Confirmation Order Email (including to download the Malaysia Airlines Mobile Application from Apple App Store & Google Play Store) and proceed with appointment booking as per below:

- a. Enrich Member to contact the preferred Malaysian Optimax outlet to book an appointment at least 2 days in advance.
- b. When making payment, Enrich Member must present the Enrich Optimax RM100 e-Voucher(s) at the Optimax outlet payment counter.
- c. The staff at the Optimax outlet payment counter will swipe the "Redeem" tab on the Enrich Optimax RM100 e-Voucher.
- d. Once successful, the total amount of Enrich Optimax RM100 e-Voucher(s) redeemed will be deducted from the total bill.
- e. Enrich Member is responsible to pay any difference of the total bill over and above the amount of redeemed Enrich Optimax RM100 e-Voucher by cash or credit card, whichever is accepted at the Optimax outlet. Other payment types such as e-Wallet is subject to the acceptance of the Optimax outlet.
- 4. The "Redeem" tab on the Enrich Optimax RM100 e-Voucher can be swiped **ONCE** only. The Enrich Optimax RM100 e-Voucher is considered used once the "Redeem" tab is swiped. This action cannot be reversed.
- 5. The Enrich Optimax RM100 e-Voucher(s) is good for a one-time purchase only.

- 14. Reports on any issues pertaining to the Enrich Optimax RM100 e-Voucher (s) redemption are to be made within seven (07) days from the date of redemption. Any reports or requests made after seven (07) days from the date of redemption will not be entertained.
