



# **TERMS AND CONDITIONS**

## ENRICH KAPTEN BATIK RM50 E-VOUCHER REDEMPTION

 The Redemption of Enrich Kapten Batik RM50 e-voucher for Kapten Batik is organized by Enrich, Malaysia Airlines Berhad (Company No. 201401040794 (1116944-X) a company incorporated in Malaysia of having its registered office at Level 1, South Support Zone, 64000 Sepang, Selangor, Malaysia (hereinafter referred to "Organizer")

### And

Kapten Batik (M) Sdn Bhd (Company No. 1295865-D), a company incorporated in Malaysia and address at Lot 2-079A, Endah Parade, Jalan 1/149E, Taman Sri Endah Bandar Baru Sri Petaling, 57000 Kuala Lumpur (hereinafter referred to as "Kapten Batik")

Redemption Period: Now until 28<sup>th</sup> February 2025 (11:59 PM, Malaysia Time) Usage Period : Six (06) months from date of successful redemption

The Enrich Kapten Batik RM50 e-voucher for Kapten Batik is herein referred as "Enrich Kapten Batik RM50 e-voucher" in this Terms and Conditions.

#### [A] Redemption of Enrich Kapten Batik RM50 e-voucher

- 1. The Enrich Kapten Batik RM50 e-voucher is available for redemption during the campaign period published in Enrich Website in a denomination offered with the amount of Enrich Points required specified in the campaign terms and conditions.
- 2. The amount of Enrich Points for this campaign is **3,000 Enrich Points for one (1) x Enrich Kapten Batik RM50** e-voucher.
- 3. The Enrich Kapten Batik RM50 e-voucher can only be redeemed at Enrich Online (<u>https://www.malaysiaairlines.com/enrich-portal/login.html</u>) and Malaysia Airlines mobile app. The e-voucher may not be redeemed or purchased with cash or credit card directly at any Kapten Batik outlets.
- 4. Once redeemed, the Enrich Kapten Batik RM50 e-voucher is non-transferable, non-refundable and cannot be exchanged for cash in part or full.

- 2. Combination of multiple Enrich Kapten Batik RM50 e-voucher (s), up to 50 e-Vouchers, is allowed in a single transaction
- 3. In order to utilize the e-voucher at physical stores, Enrich member is required to follow the steps below:
  - i. Download the Malaysia Airlines mobile app from Google Play Store or App Store
  - ii. Login to Malaysia Airlines mobile app.
  - iii. Tab on MHvoucher, then select My Voucher to view your Active Voucher.
  - iv. Select the voucher to utilize and click 'USE NOW'.
  - v. The camera function will prompt and scan the unique QR code at outlet.
  - vi. Present the codes to the Cashier upon payment.
  - vii. Once successful, RM50 will be deducted from the total bill.
  - viii. The e-voucher can only be used by the member who redeems the e-voucher. Transfer of the e-voucher to other Enrich member (s) is not allowed.
  - ix. Should the RM50 e-voucher not appear in Malaysia Airlines mobile app, Enrich member required to uninstall and reinstall the Malaysia Airlines mobile app. Once ready, please repeat the above step (ii) until (viii) to redeem the e-voucher.

Note: Please ensure you are at the Kapten Batik's outlets to scan the unique QR code. Unique QR code is different at each outlet.

- 4. The Enrich Kapten Batik RM50 e-voucher can be used **ONCE only**. It is considered used once the code is displayed. This action cannot be reversed.
- 5. The Enrich Kapten Batik RM50 e-voucher (s) is good for a one-time purchase only.
- 6. No minimum purchase is required to redeem the Enrich Kapten Batik RM50 e-voucher.
  - If the total purchase is less than the value of Enrich Kapten Batik RM50 e-voucher, no refunds will be allowed.
  - If the total purchase is more than the value of the Enrich Kapten Batik RM50 e-voucher, member is required to top-up and pay any difference by cash/credit card that is accepted at Kapten Batik outlets.
