



BHPETROL E-VOUCHER REDEMPTION

Terms and Conditions

1. Organiser

The BHPetrol E-Voucher Redemption ("Promotion") is organised by Enrich by Malaysia Airlines Berhad ("Organiser").

i. The Enrich and BHPetrol e-voucher(s) Redemption is organised by Enrich by Malaysia Airlines Berhad (Company No. 201401040794 (1116944-X)), a company incorporated in Malaysia of having its registered office at Level 1, South Support Zone, 64000 Sepang, Selangor, Malaysia (hereinafter referred to "Organiser").

and

- Enrich members must be logged in to Malaysia Airlines app and Enrich Online (https://enrich.malaysiaairlines.com/login).
- Only redemption made via Malaysia Airlines app and Enrich Online are eligible.
- Enrich Member must have sufficient Enrich Points in their Enrich account to redeem the BHPetrol e-voucher(s). In the event, Enrich Member do not have sufficient Enrich Points, redemption request will not be processed and top up with cash/credit card is strictly not allowed.

6. Usage of BHPetrol e-voucher

- The BHPetrol RM50 e-Voucher(s) is applicable on fuel and items sold at all BHPetrol stations in Malaysia, as listed in https://www.bhpetrol.com.my/find-a-station/
- In order to utilise the BHPetrol e-voucher(s), Enrich Member is required to follow below steps:
 - a) Login to Malaysia Airlines mobile app.
 - b) Tap on MHvoucher, then select My Voucher to view your Active Voucher.
 - c) Select the e-voucher to utilize and click 'USE NOW.
 - d) The e-voucher code will appear.
 - e) Present the e-voucher code to the Cashier upon payment.
 - f) Once successful, RM50 will be deducted from the total bill.

Note: Please ensure you are at the merchant station before you click 'USE NOW'. The 'USE NOW' tab can only be clicked **ONCE** and this action cannot be reversed.

- Combination of multiple BHPetrol e-voucher(s) is allowed in a single transaction.
- The BHPetrol e-voucher is valid on full priced items only and is not applicable with other vouchers, promotions, or discounts.
- The BHPetrol e-voucher(s) is good for a one-time purchase only.
- No minimum purchase is required to redeem the BHPetrol e-voucher:
 - a) If the total purchase is less than the value of the BHPetrol e-voucher, no refunds will be allowed.
