



TERMS AND CONDITIONS

ENRICH ROYAL SELANGOR E-VOUCHER REDEMPTION

[A] Redemption of Enrich Royal Selangor e-voucher

- 1. The Enrich Royal Selangor e-voucher is available for redemption during the campaign period published in Enrich Website in a denomination offered with the amount of Enrich Points required specified in the campaign terms and conditions.
- 2. The amount of Enrich Points required for the Enrich Royal Selangor's e-voucher is as follows:
 - 3,000 Enrich Points for one (1) RM 50 Enrich Royal Selangor's e-voucher
 - 6,000 Enrich Points for one (1) RM 100 Enrich Royal Selangor's e-voucher
- 3. The campaign period is as follows:

Redemption period: 01 May 2025 – 30 April 2026 11:59 PM Usage period: 01 May 2025 – 30 April 2026 11:59 PM

- 4. The Enrich Royal Selangor e-voucher can only be redeemed at Enrich Online (<u>https://www.malaysiaairlines.com/enrich-portal/login.html</u>) and Malaysia Airlines mobile app. The e-voucher may not be redeemed or purchased with cash or credit card directly at any Royal Selangor outlets.
- 5. Once redeemed, the Enrich Royal Selangor e-voucher is non-transferable, non-refundable and cannot be exchanged for cash in part or full.
- 6. The appropriate number of Enrich Points will be deducted from the member's Enrich account and will not be refunded under any circumstances. Once the Enrich Royal Selangor e-voucher has been redeemed, it is considered utilized even if not used.
- 7. Enrich Member must have sufficient Points in their Enrich account to redeem the Enrich Royal Selangor evoucher. In the event, member do not have sufficient Points, the redemption request will not be processed and top up with cash/credit card is strictly not allowed.
- 8. The Redemption is on full Points term only; no Points + Cash terms is allowed.
- 9. There is no limit to the number of Enrich Royal Selangor e-voucher (s) to be redeemed as long as Enrich Points are sufficient in member's account.
- 10. Once redemption is successful, a Redemption Confirmation Order Email will be sent to the member's registered email address in the Enrich profile.

[B] Usage of Enrich Royal Selangor e-voucher

- 1. The Enrich Royal Selangor e-voucher (s) is valid at Royal Selangor outlets for any of product(s) excluding new collections and limited-edition items during the campaign period as per **Schedule A**.
- 2. Combination of multiple Enrich Royal Selangor e-voucher (s) is allowed in a single transaction.
- 3. In order to utilize the e-voucher at physical stores, Enrich member is required to follow the steps below:
 - i. Download the Malaysia Airlines mobile app from Google Play Store or App Store
 - ii. Login to Malaysia Airlines mobile app.
 - iii. Tab on MHvoucher, then select My Voucher to view your Active Voucher.
 - iv. Select the voucher to utilize and click 'USE NOW'.
 - v. The camera function will prompt and scan the unique QR code at outlet.
 - vi. Present the codes to the Cashier upon payment.
 - vii. Once successful, RM50 or RM100 will be deducted from the total bill.
 - viii. The e-voucher can only be used by the member who redeems the e-voucher. Transfer of the e-voucher to other Enrich member (s) is not allowed.

ix. Should the RM50 or RM100 e-voucher not appear in Malaysia Airlines mobile app, Enrich member required to uninstall and reinstall the Malaysia Airlines mobile app. Once ready, please repeat the above step (ii) until (vii) to redeem the e-voucher.

Note: Please ensure you are at the Royal Selangor's outlets to scan the unique QR code. Unique QR code is different at each outlet.

- 4. The Enrich Royal Selangor e-voucher can be used **ONCE only**. It is considered used once the code is displayed. This action cannot be reversed.
- 5. The Enrich Royal Selangor e-voucher (s) is good for a one-time purchase only.
- 6. No minimum purchase is required to redeem the Enrich Royal Selangor e-voucher.
 - If the total purchase is less than the value of Enrich Royal Selangor e-voucher, no refunds will be allowed.
 - If the total purchase is more than the value of the Enrich Royal Selangor e-voucher, member is required to top-up and pay any difference by cash/credit card that is accepted at Royal Selangor outlets.
- 7. The Enrich Royal Selangor e-voucher can only be used for payment excluding any taxes or service charges. The taxes or service charges should be paid by the member either in cash or credit separately.

 - Incorrectly redeeming this e-voucher;
 - discontinued or cancelled e-voucher;

 - the inability to use a e-voucher due to technical issues
- 11. Enrich will not be liable for any defect or damage item purchase at Royal Selangor to the Enrich member.
